We will collect and process the following data about you from:

Information you give us:

-This is information about you that you give us by filling in forms on our website Fiper.me.com (our site) or by corresponding with us by phone, e-mail or otherwise. It includes information you provide when you register to use our website, when you report a problem with our site or when you contact us to discuss any aspect of your account with us.

-The information you give us may include your name, address, date of birth, e-mail address and phone number, financial, tax and payment information, personal data and photograph ID or other information. Information we collect about you we will use as follows:
