The Company is in Good Standing in Saint Vincent and the Grenadines as of July, 2021 confirm that the Company can offer the said Services legally and does not require a financial licence under the laws of Saint Vincent and the Grenadines to conduct such Services.
- 5. We further confirm that the business activities of the Company as set out and stipulated in its operating agreement do not infringe or contradict any local laws of Saint Vincent and the Grenadines, according to the information presented to us.
- 6. The Company has a registered office in the State of Saint Vincent and the Grenadines and its registered agent's address are also at the following location: Griffith Corporate Centre, P. O. Box 1550, Beachmont, Kingstown, St. Vincent and the Grenadines.
